Josh Russo, Recreational Abalone Advisory Committee Member, Waterman's Alliance, & Sonoma County Abalone Network, provided updates on the abalone management plan development. Public meetings will occur in July and August to present plan progress. Mr. Russo offered comments and answered questions regarding efforts to educate divers on regulations, closure updates, etc. He reported his concerns regarding the efforts of some groups to relocate sea otters to northern California, stressing the need to address the issue within the management plan.

Commissioner Neumann reported on the progress and challenges of Reef Check California to train volunteers and conduct data collection.

• Mendocino Wildlife Association, Woodlands Wildlife, and Other Cooperative Agencies

Tracy Pellar provided an update on the Mendocino Wildlife Association. She passed out the new brochure, reported on the efforts to certify rehabilitation volunteers, and noted a coalition letter regarding the prevention of cannabis growing in range lands. She offered an update on the bear proofing of refuse receptacles and will continue to report progress to the Commission.

5. Discussion and Possible Action Regarding Burn Symposium (Guerrero)

Commissioner Guerrero reported on the recent meeting with Mendocino County Farm Bureau representatives Devon Jones, Executive Director, and Frost Pauli, Board President. The proposed date range for the co-sponsored burn symposium is November 15-17, 2017. Participants may include CALFIRE and Air Quality Management District. Commissioner Madigan suggested coordinating with Mendocino Resource Conservation District and the USDA Natural Resources Conservation Service. Commissioner Guerrero summarized the purpose of the burn symposium is to educate landowners on how to conduct personal prescribed fire on their property outside of the burning season to improve wildlife management without using management agency, Federal, or State funds that trigger the need for California Environmental Quality Act (CEQA) regulations.

Upon motion by Commissioner Madigan, second by Commissioner Guerrero, an expenditure to cosponsor the burn symposium with Mendocino Farm Bureau not to exceed \$300 was approved by unanimous vote:
