1. Call to Order and Roll Call: Vice Chair Guerrero called the meeting to order at 6:02pm.

Josh Russo, Recreational Abalone Advisor Committee Member, Waterman's Alliance, & Sonoma County Abalone Network, provided follow up on the costal meeting in December informing the public of the 2017 abalone regulation changes. He reported on additional efforts to develop regulatory actions and keep the public informed and involved. He asked the Commission to write a letter to encourage the California Fish and Game Commission to consider regulatory action or changes to the 2018 season. He suggest the Commission write a letter to the Fort Bragg Chamber of Commerce, encouraging local businesses to become involved in the support of regulatory development in order to prevent closure of April and November from the abalone season. He also discussed the challenges in the development of the Fisheries Management Plan.
