**Presenter/s:** Dr. Wilbanks referenced the MCERA Strategic Plan and provided a brief overview of the topics to be discussed during this special two day meeting.

Mr. Berk provided an educational presentation on Fiduciary Duty which included discussion of Proposition 162, following adopted policy and procedures, and applicable laws, conducting investment manager searches and diversification of assets, continuing education, consulting with experts, service provider review, and the Board's primary duty pursuant to the California Constitution, Article XVI, Section 17(b).

Dr. Wilbanks conducted a review of the Board's Mission Statement and Guiding Principles. Following this discussion, information regarding some of the history of the Association was discussed for the benefit of new trustees. Strategic plan review continued and discussion included MCERA accomplishments, trustee and staff strengths including Strengths Finder 2.0 results, board duty prioritization, the MCERA Service Model, MCERA strengths, weaknesses, opportunities, and threats (SWOT), and the current Board Work Plan.

Trustees compiled a lengthy list of potential new projects and reviewed the Staff Work Plan. Dr. Wilbanks referenced the MCERA website and presented trustee photos and biographies. He also provided a preview of the new MCERA monthly newsletter which will be released to members soon. Following discussion of the Staff Work Plan and upcoming projects it was agreed that the new project list will be brought back for additional discussion and prioritization at a future board meeting and will be incorporated into the Board Work Plan at that time.
