The post-supervision column indicates whether a sentence has been "split," meaning the defendant's overall sentence is split by order of the Court between time incarcerated in the county jail and time on mandatory supervision upon release. If the defendant's sentence is <u>not</u> split, then he or she will not have any probation or parole-like supervision upon completion of their full sentence.
