PCCY recommendation of Appointment of Interest Application to BOS: Seat #12 – Private Non-Profit Corporation Serving Children & Youth – Roseanne Ibarra

HEROS PROJECT 2017:

Sheryn Hildebrand passed out "Inside/Outside" a letter from prison by John Mendoza. She explained that the comic style book is a powerful story about a local Mendocino County youth that is currently in prison. The book encourages youth to make good decisions and was sponsored by Mendocino County Juvenile Justice and Delinquency Prevention Commission, Heroes for Youth and CASA. BY-LAW REVIEW COMMITTEE:

Sheryn Hildebrand passed out copies of PCCY/CAPY current By-laws and asked for members to join the sub-committee. Two items need to be reviewed; meeting dates and status report. No one volunteered to be on the committee so Sheryn said she will send out emails regarding this item. She would like to review the By-laws in two weeks and is willing to do this via teleconference. The proposed changes will be on the February agenda. She asked that all members review the By-laws and send any suggested changes to her.

UC DAVIS ORGANIZATIONAL ASSESSMENT:

Anne Molgaard gave a brief overview of the assessment, by Northern California Training Academy UC Davis, which was conducted to evaluate the overall effectiveness of Mendocino's FCS and to highlight areas working well and provide recommendations for organizational improvements. Anne asked if members felt there was anything missing or any questions about the report. Discussion was held and the following items were suggested by the commission.

- Pg. 67-68 an updated calendar of proposed tasks and activities be provided
- That HHSA/F&C management informs the BOS clearly of their vulnerabilities and needs.
- Pg. 60 court reports are made available using a digitally encrypted communication system.
- PCCY/CAPC heartedly endorses that FCS be open 5 days a week.

The report will be presented to the BOS on February 14, 2017.
