BACA PRESENTATION:

Preacher and Bones presented Bikers Against Child Abuse, Inc. (B.A.C.A.) a non-profit, 501-C-3 tax exempt organization that exists to provide aid, comfort, safety, and support for children that have been sexually, physically, and emotionally abused. They are dedicated to the principle that one of the basic rights of childhood is to be safe and protected, and when the child's family or environment have failed them, they stand ready to provide it to them.

B.A.C.A. is a strong organization of dedicated individuals who are willing to sacrifice any and all in order to protect and secure a child's basic right to a happy childhood. All member applicants must submit to and pass a federal fingerprint background check. They must attend B.A.C.A. meetings and events during their first year and must be unanimously approved worthy by a Board of Directors. Further protection is implemented by policy that does not allow any one Member to be alone with a child, ever.

B.A.C.A. Mission Statement

Bikers Against Child Abuse, Inc. (B.A.C.A.) exists with the intent to create a safer environment for abused children. We exist as a body of Bikers to empower children to not feel afraid of the world in which they live. We stand ready to lend support to our

wounded friends by involving them with an established, united organization. We work in conjunction with local and state officials who are already in place to protect children. We desire to send a clear message to all involved with the abused child that this child is part of our organization, and that we are prepared to lend our physical and emotional support to them by affiliation, and our physical presence. We stand at the ready to shield these children from further abuse. We do not condone the use of violence or physical force in any manner, however, if circumstances arise such that we are the only obstacle preventing a child from further abuse, we stand ready to be that obstacle.

Children's Health Committee (CHC) – Megan Van Sant was unable to attend the meeting and sent updates from the January meeting for distribution.

UC Davis Organizational Assessment – Jena Conner reported that the presentation to the BOS has been set for April 18th. She will have a new calendar/timeline to share with the committee at the March meeting.

Teri Sedrick shared that the week of the young child is scheduled for April 22nd.
