OPEN MEETING/CALL TO ORDER/ADDITIONS TO THE AGENDA

Teri Sedrick noted that the week of the young child was not being presented by Head Start as stated in the minutes and asked that the correction be made.

RFA PRESENTATION:

Jena Conner passed out copies of a PowerPoint, "Mendocino County FCS Resource Family Approval Overview" to all. Jena then reviewed the document, noting that;

- RFA is a new State requirement for approving all individuals/families, including relatives and nonrelative extended family members, to care for foster children/youth in out-of-home placement as of 1-1-17.
- The new process unifies approval standards for all caregivers.
- RFA is part of the Continuum of Care Reform (designed out of an understanding that children who must live apart from their biological parents do best when they are cared for in committed nurturing family homes).
- Eliminates duplication.
- Prepares families to better meet the needs of vulnerable children.
- Allows seamless transition to permanency.

- All will be "Resource Families".
- RFA components include: home environment assessment, permanency assessment and background check assessment.
- Homes approved or who began the approval process prior to January 1, 2017 must convert to a Resource Family Home by December 2019
- Existing Foster Parents will receive notification by July laying out a timeline for their conversion process.

BY-LAW RECOMMENDATION:

Chairperson Sheryn Hildebrand inquired if members had any questions of the recommended Bylaw changes. There was discussion and it was decided to change pg. 11 bullet at bottom of page to "All nonprofit proposals to utilize the \$3,000.00 reserve are required to be submitted prior to the first meeting of the calendar year". Joy Beeler will make the change and the item will be agendized for the April meeting. It was noted that Lake County's Children's Council would like to have a joint meeting with PCCY at least once per year.

REPORTS:

Children's Action Committee (CAC) – Sheryn Hildebrand reported that CAC is holding a pinwheel contest to coincide with April's Child Abuse Prevention month. Tuesday, April 18th is set to present the annual report to the BOS from 11-12pm and she encourages everyone to attend.

Schuyler Marcier from the Arbor Resource Center shared plans to hold an essay contest; open to all youth ages 12-18 as a follow up to the publication "Inside/Outside". Entries are due May 5^{th.} Contact Schuyler Marcier 462-7267 for more information.
