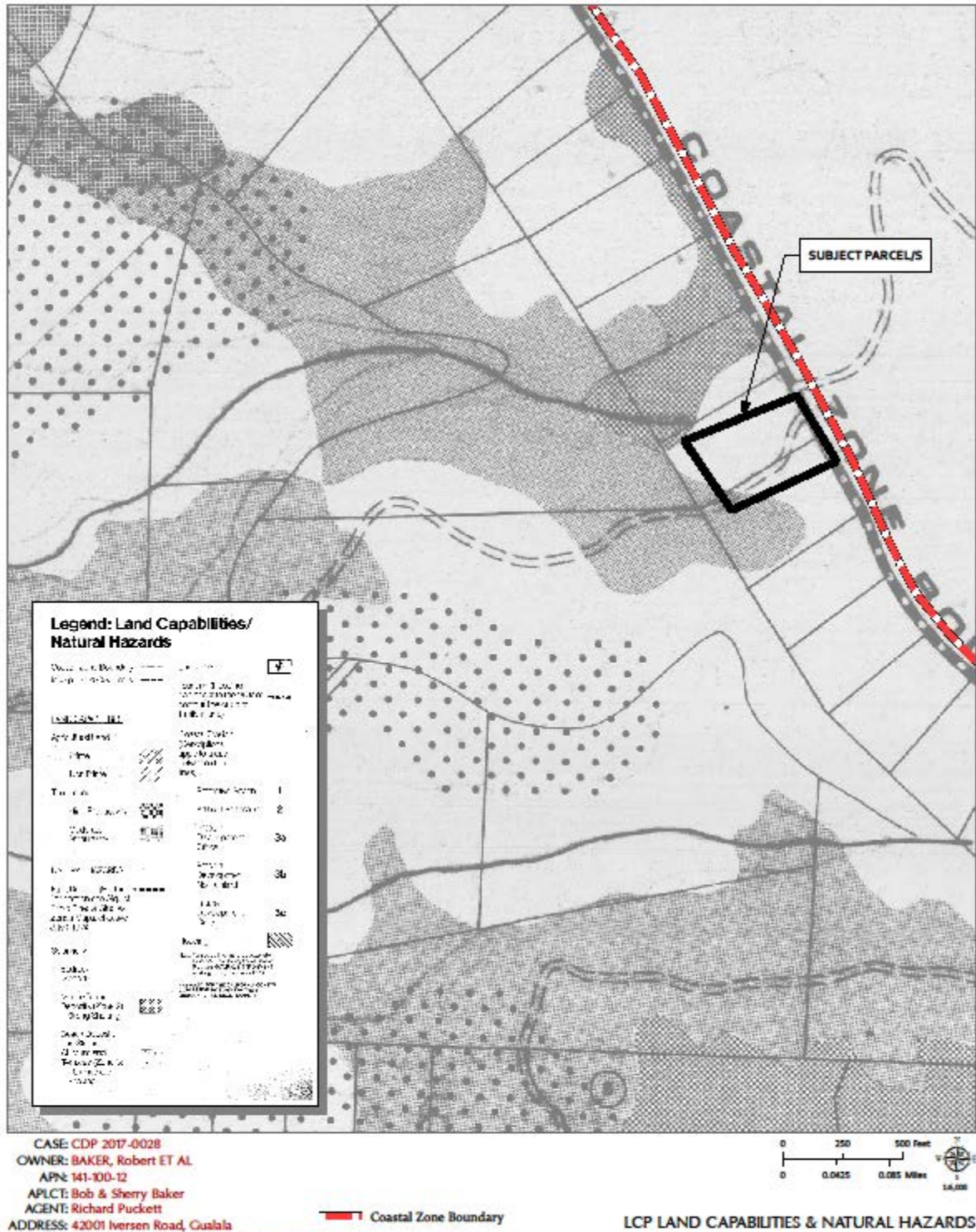
1 Coastal Zone Boundary

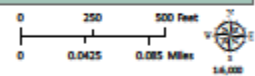
STRUCTURE PROFILE

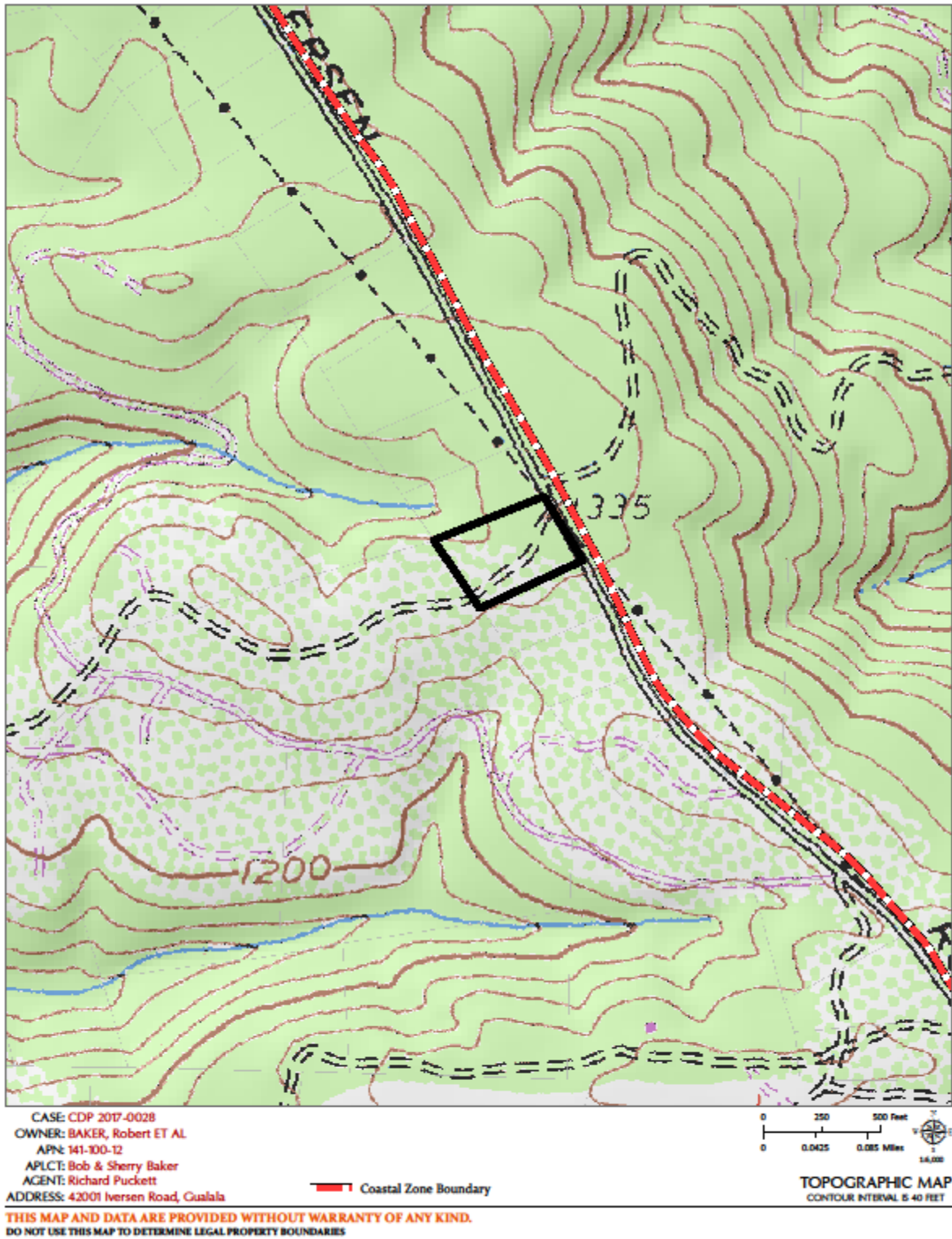
Western Soil Classes

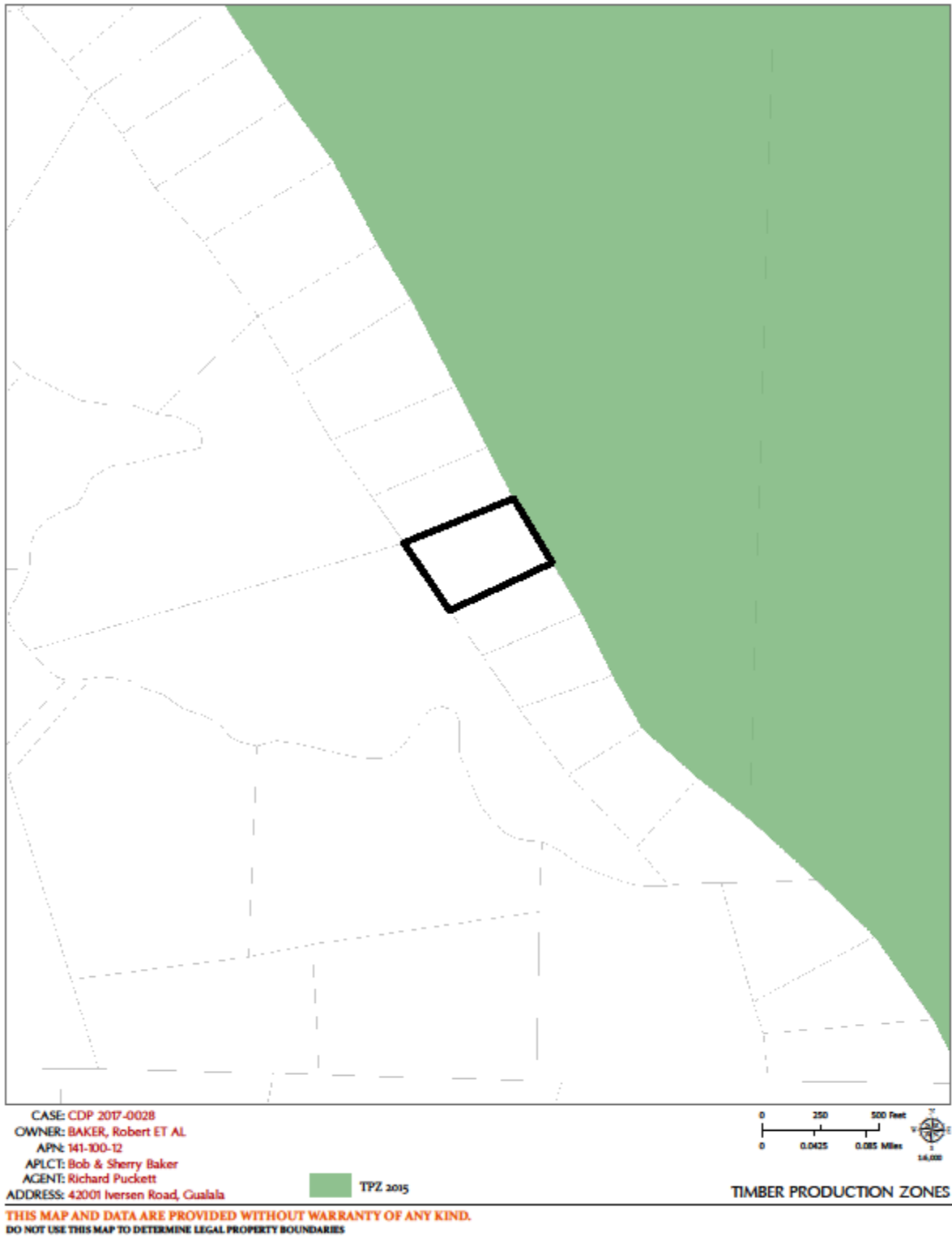
