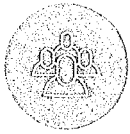

### MEMBERSHIP AND APPOINTMENT DETAILS

#### MEMBERSHIP

Members of the Advisory Board shall be selected and appointed by the Mendocino County Board of Supervisors from a list of nominees prepared by the Board of Directors of the Mendocino County Lodging Association. Five persons; two members representing the inland area; two members representing the coastal region; and one member representing the Mendocino County Lodging Association.

**APPOINTED**

The Board of Supervisors, from a list of nominees prepared by the Board of Directors of the Mendocino County Lodging Association. Per County Counsel no vacancy noticing is required due to mandated membership nomination process. The initial members of the Advisory Board shall serve staggered terms, with two members serving a one-year term and three members serving a two-year term. The length of the term for each individual member of the Initial Advisory Board shall be chosen by a lot at the first meeting of the Advisory Board. Thereafter, all members subsequently appointed shall serve two-year terms.

**MEETS****FUNCTION**

The Advisory Board shall attempt to submit it's annual report to the Board of Supervisors at least 90 days preceding the fiscal year for which assessments are to be levied and collected to pay the costs of the improvements and activities described in the report. The Board of Supervisors authorizes the CEO or designee to convene the Advisory Board, approve the bylaws, and approve the annual work plan for the Advisory Board.
