



# Food Safety Manager Certification Class

California law (CALCode) 113947 requires at least one owner or one employee in every food establishment to be certified as a Food Safety Manager.



- No Certified Person at a Food Facility may serve at any other Food Facility as the person required to be certified pursuant to this subdivision.
- A Food Facility that commences operation, changes ownership or no longer has a certified owner or employee pursuant to this section, shall have 60 days to comply with this subdivision.
- The responsibilities of the certified owner or employee at a Food Facility shall include the safety of food preparation and service, including ensuring that all employees who handle or have responsibility for handling non-prepackaged food of any kind, have sufficient knowledge to ensure the safe preparation or service of the food.
- The Food Safety Certificate issued pursuant to §113947.3 shall be retained on file at the Food Facility at all times, and shall be made available for inspection by the enforcement officer.

Certified individuals shall be recertified every 5 years by passing an approved and accredited food safety certification examination.
