**STATEMENT**

I, \_\_\_\_\_, understand that my name may be placed in nomination to be considered for membership on the Civil Grand Jury of Mendocino County for the Fiscal Year of 2019/2020 and that I will be required to attend an orientation program for all Civil Grand Jury applicants.

I am aware that such service requires that I be in attendance 15 – 25 hours per week. In this regard, I understand that as a grand juror I must be flexible and able to serve some evening and weekend hours, as well as working during normal business hours. I understand that it is essential that all Civil Grand Jury members be in attendance at all meetings, and only the most pressing emergency or my illness would be reasons for absence. I declare, pursuant to Penal Code § 896(a), that I will be available to serve during those required hours.

Each member of the Civil Grand Jury shall be allowed \$25.00 (taxable) for each full panel meeting and \$10.00 (taxable) for each committee or investigative meeting of the Civil Grand Jury, not to exceed \$25.00. Mileage expense is compensated at the rate payable to employees of the County of Mendocino for each mile actually and necessarily traveled for purposes of said sessions or committee work.

I am aware that, if selected as a grand juror, I will be required to file the Fair Political Practices Commission's Form 700 (pursuant to Government Code Sections 81000-91014).

Now, therefore, I have read and understand the above, and I hereby state that I have no commitments which would prevent me from meeting the requirements for service on the Mendocino County Civil Grand Jury.

I recognize that my attendance will be expected and may be required by the Foreperson of the Civil Grand Jury.

I therefore request that I be considered as a candidate for the Civil Grand Jury of Mendocino County for the Fiscal Year 2019/2020.
