Option 2

Based on stakeholder feedback, the County is requiring bidders submit an option that does not include interfacility transports (IFT) at any level (i.e., BLS, ALS, or CCT).

Proposal Format

Within each proposal, respond to the original RFP model as well as include the system status plan, base rates, and other relevant information for Option 1: shorter response times and Option 2: EOA without IFT. If necessary, bidders should include the impact if both options are accepted by the County. For example, in Section 8.4.(f) Response-Time Commitment, the proposal should include separate answers for the 1) original RFP criteria, 2) shorter response times, 3) EOA without IFT, as well as 4) both shorter response times and EOA without IFT (only necessary if the combination of the two options has a different answer). The proposals will be scored by the evaluators based

on the original RFP model. The County may decide to accept one, both, or none of the options proposed.
