Fee Payment

Within 10 calendar days of submitting your application, you must pay an application fee in order for your application to be complete.

Your fee category is: Tier 1 Low Risk. Your application fee is \$600.00.

nstructions for Paying Application Fees by Cash:

All cash payments must be submitted directly to the State Water Resources Control Board (State Water Board), not the Regional Water Quality Control Board. The State Water Board piefers that payments be made by check or money order. Money orders are savailable in

large denominations (up to \$1,000) at many local retail outlets and post offices across California and, if used, will expedite the enrollment process. The State Water Board is able to accept cash payments at its downtown Sacramento location. Cash payments, however, will require additional time and an appointment with the State Water Board Sacramento office. A delay in enrollment due to the need for a cash payment is not an excuse for non-compliance with applicable enrollment requirements. 1) Site Management Plan - due within 90 days of application submittal

Compliance with Best Practicable Treatment or Control (BPTC) Measures

(Winter period is defined in Attachment A of the Cannabis General Order.) You are required to contact the Regional Water Board to establish a compliance schedule.
