Subject: Administrative Report

PG&E Potential Public Safety Power Shutoff

With the announcement by Pacific Gas & Electric (PG&E) of the potential for a Public Safety Power Shutoff, we are reviewing the MCERA Business Continuity Plan (BCP) to ensure critical operations are not impacted. We are reviewing options with the County and will provide an update to the Board during the meeting.

As a reminder, the MCERA owned building does not have a back-up generator. The Board discussed installing one during a previous budget cycle, but decided against it. In light of new plans by PG&E, if the Board wishes to revisit that decision, we can certainly investigate the options and bring the information and a recommendation back to the Board.

MCERA Travel Policy

Since the Board adopted its Travel Policy in January, 2019 we have learned that there are a myriad of complications with the implementation of the policy. The County is currently working on an update of its Travel Policy as well as a policy for County employees serving on Boards such as MCERA.

Until these policies are amended or adopted, I plan to leave our policy in place with the understanding that County employees on the MCERA Board are still subject to the County Travel Policy and MCERA Trustees that are not County employees are subject to the MCERA Travel Policy. As soon as the County resolves its policies, I will review, and likely revise, the MCERA Travel Policy to eliminate potential conflict with the County policies.
