#### 1. Roll Call.

The meeting was called to order at 9:02 a.m.

#### 2. Planning Commission Administration.

2a. Determination of Legal Notice.

The Clerk advised the Commission that all items had been properly noticed.

# 3. Director's Report and Miscellaneous.

Mr. Schultz introduced Administrative Services Manager, Adrienne Thompson to provide an update regarding the 2017 and 2018 fires.

Ms Adrienne Thompson informed the Planning Commission that she was designated to be the fire task force lead and in this capacity maintained all information related to debris records and permitting. She stated that 74 administrative permit applications were received for temporary dwellings in the fire area, 69 of those permits have been issued, 2 withdrawn and 1 in progress and 1 pending approval. Ms. Thompson noted that additional applications have been received due to the FEMA program ending. She also stated that 165 building permits have been issued: 76 single family residences, 46 manufactured homes, and 43 accessory structures. She added that 58 of those permits have been finaled: 29 manufactured homes, 12 single family residences, and 17 accessory structures.

Commissioner Wiedemann inquired about how many needed still needed to be replaced.

Ms. Thompson responded that roughly one-third of the 349 homes and 295 accessory structures destroyed have been rebuilt.

#### 6a. CASE#: U 2016-0003

OWNER/APPLICANT: RURAL COMMUNITIES HOUSING DEVELOPMENT CORP. (RCHDC)

AGENT: RYAN LARUE

REQUEST: Modification of the Conditions of Approval of U\_2016-0003 to allow for project phasing at the discretion of the Planning and Building Services Director. U\_2016-0003 authorized the implementation of a Planned Development to construct an 80 unit Senior Housing Project "Orr Creek Commons", community building and linear park along Orr Creek.

<u>LOCATION:</u> Bordering the Ukiah City limits, lying on the south side of Brush St (CR 217) at the eastern intersection of Orr St (CR 216), approximately 250 feet from the intersection of Orchard Ave (City Limits) to the west. The property is bounded on the south by approximately 1,000 feet of Orr Creek, which defines the limits between the City and County.

ENVIRONMENTAL DETERMINATION: Addendum to Mitigated Negative Declaration

STAFF PLANNER: JULIA ACKER

Ms. Acker Krog, Chief Planner, shared that the project was a modification to a previously approved Use Permit. She stated that some challenges relating to the project were discovered and requested a continuance of the project to a date uncertain.

Director Schultz stated that in addition to the continuance request the project would likely be brought back to the Commission in April as approval would be needed before June due to funding timelines.
