He advised that two sites were identified for three uses; and the architect will be asked to evaluate and provide design-related services including the appropriate environmental and CEQA documentation, site analysis for each of the two sites currently being identified, programming and planning accessibility, mechanical, electrical, and plumbing, etc. Because this is a public project, CEQA will also apply. Responding to various questions from the Committee regarding estimated time-frame, Mr. Gonzalez stated that 60-90 days was a realistic timeframe to have this completed; approximately 30 days for the RFP; and finally 60-90 days for contract evaluation and award. The Committee expressed concerns regarding the amount of time necessary to work through the process. Mr. Gonzalez and Ms. Angelo clarified that all were steps both required and necessary to move forward with the process.

Sheriff Allman described the building and proposed use, and stated that it would be used as both a regional behavioral health training facility as well as a Sheriff's office sub-station for deputies. He continued that although the building is not turn-key, he anticipated it could be opened and ready to house trainings by January 1, 2020.

The Committee discussed the building, suitability, as well as the types of trainings that could be held at the facility including NAMI, Mental Health, etc. Members agreed that having a dedicated behavioral health training facility would be extremely beneficial as there is currently a lack of available locations. Discussion also focused on potentially partnering with other local agencies, entities, medical, educational, in lieu of purchasing a facility at this time, as well as prioritizing the training center over Mental Health Services. Ms. McNamara stated that there were several offers pending on this property. The need for an expedited decision was discussed as Ms. McNamara confirmed that there were several offers pending on this property.

Mr. Gonzalez then led the Committee through possible building use/zoning requirements; and CEO Angelo detailed the approval/purchase process via the Board of Supervisors

SUMMARY OF REQUEST / BACKGROUND INFORMATION:

On July 8, 2019, the Mental Health Treatment Act Citizen's Oversight Committee approved a recommendation to the Mendocino County Board of Supervisors for the purchase of real property located at 8207 East Road, Redwood Valley, California to be used as a regional behavioral health training facility/Sheriff's office sub-station with 70% funds from Measure B; and 30% from the Sheriff's office budget.

On July 16, 2019, the Board of Supervisors approved the allocations of up to \$278,000 of Measure B Funds and up to \$150,000 of Sheriff's Office Asset Forfeiture Balance for the purchase of Real Property located at 8207 East Road, Redwood Valley for a Regional Behavioral Health Training Facility/Mendocino County Sheriff Sub-station; and in Closed Session authorized the acquisition of Real Property located at APN: 163-140-14; 8207 East Road, Redwood Valley, CA for the purchase price of \$389,000.

SUMMARY OF REQUEST / BACKGROUND INFORMATION:

The Ad hoc committee will provide an update on the status of the Ad Hoc Committee since formation on May 22, 2019.

On May 22, 2019, the Mental Health Treatment Act Citizen's Oversight Committee formed an Ad Hoc Committee consisting of Members McGourty, Diamond, Miller and Moschetti to review the Kemper Report Recommendations. The Committee shall exclude study of any services; and should not usurp the original recommendation of the Measure B Committee to move forward with the feasibility study of original recommendation to the Board of Supervisors.

Measure B ad hoc Committee

to study the Kemper Report for Administrative recommendations

Mendocino County Behavioral Health System Program Gap Analysis & Recommendations for Allocation of Measure B Revenues

by Kemper Consulting Group ◆ August 2018

The ad hoc committee met on Wednesday, May 15, 2019. Present were: Jan McGourty, Jenine Miller, Donna Moschetti, and Carmel Angelo. We went through the Study Guide prepared for the Measure B Committee on Kemper's Recommendations for Action & Policy (page 43 of his report) and Proposed Strategic Financing Plan (page 44). It was noted that a couple of the items proposed on the latter were already in effect, so the ad hoc committee chose to concentrate on the financial items, deliberately ignoring anything regarding services as directed by the Measure B Committee. The concluding recommendations to the Measure B Committee, which in turn should be approved and forwarded to the Board of Supervisors, were as follows:

- 1) Maintain a prudent reserve of Measure B funds (Kemper page 43 #3 and page 44 #8)) Maintain a reserve of 12.5% of all Measure B funds beginning now and continuing for the life of the project. 12.5% is the amount the California Governor sets aside, which is less than half required by MHSA (33%) so it seems like a reasonable amount.
- 2) Separate annual accounting of Measure B revenues/expenditures (Kemper page 43 #4) The County Auditor should conduct an annual accounting of Measure B funds, with an outside audit done every three to five years.
- 3) 10-Year Strategic Plan (Kemper page 43 #5). It is imperative to create a 10-year financial strategic plan for fiscal analysis as soon as possible. Kemper's Financial Plan is a good place to start.
