## Findings # 1:

As the Director of the Mendocino County Planning & Building Services I have no independent personal knowledge regarding systems that the City of Point Arena has in place for code enforcement, currently or in the past, therefore I cannot draw any conclusions about any health and safety risks that the City's residents may or may not be exposed to.

# Responses to Recommendations

### Recommendation # R1:

Due to high workload for staff addressing code violations within unincorporated areas of the county, the Board of Supervisors recently authorized the addition of a fourth code enforcement officer. However, the new position remains vacant at this time due to staff turnover. Even with the addition of this new position, Planning & Building Services is not positioned to responsibly divert scarce code enforcement resources from addressing violations within the unincorporated county. Other options are available to the City of Point Arena to contract for code enforcement services beyond working with the County. Planning & Building Services has contracted with a local expert in code enforcement that also has a background in law enforcement and legal process. A similar contractual arrangement is likely available to the City of Point Arena.

### Recommendation # R2:

As the Director of Mendocino County Planning & Building Services, I have no ability to implement this recommendation which is directed to members of the Point Arena City Council.
