I, _____, understand that my name may be placed in nomination to be considered for membership on the Grand Jury of Mendocino County for the Fiscal Year of 2016/2017 and that I will be required to attend an orientation program for all Grand Jury applicants.

I am aware that such service requires that I be in attendance 15 - 25 hours per week. In this regard, I understand that as a grand juror I must be flexible and able to serve some evening and weekend hours, as well as working during normal business hours. I understand that it is essential that all Grand Jury members be in attendance at all meetings, and only the most pressing emergency or my illness would be reasons for absence. I declare, pursuant to Penal Code §896(a), that I will be available to serve during those required hours.

Each member of the Grand Jury shall be allowed \$25.00 (taxable) for each full panel meeting and \$10.00 (taxable) for each committee or investigative meeting of the Grand Jury, not to exceed \$25.00. Mileage expense is compensated at the rate payable to employees of the County of Mendocino for each mile actually and necessarily traveled for purposes of said sessions or committee work.

I am aware that, if selected as a grand juror, I will be required to file the Fair Political Practices Commission's Form 700 (pursuant to Government Code Sections 81000-91014).

Now, therefore, I have read and understand the above, and I hereby state that I have no commitments which would prevent me from meeting the requirements for service on the Mendocino County Grand Jury.

I recognize that my attendance will be expected and may be required by the Foreperson of the Grand Jury.
