#### AGENDA ITEM No. 7 – HUMAN RESOURCES DIRECTOR REPORTS PRESENTER/S: Juanie Cranmer, Human Resources Manager

**Note:** This item was heard after Item No.4, prior to adjourning to closed session for Items 5a and 5b.

Ms. Juanie Cranmer, Human Resources Manager, stated labor negotiations have been finalized with the last bargaining unit for Department Heads going before the Board of Supervisors last week. The Board adopted a three (3) year contract, which was similar to all the other three (3) year contracts that included market adjustments that move employees to within 90, or in some cases, 95 percent of the market over the next three (3) years. The contract also includes a three percent (3%) cost of living allowance for the next three (3) years.

Ms. Cranmer stated the CEO has appointed William Schurtz, who is currently one of the Assistant HHSA Directors, as Director of Human Resources. His effective date is December 29, 2019.

William Schurtz introduced himself to the Commission, stating he has been in Human Resources for government entities for the last 20 years. He joined the Air Force right out of high school, and retired after 20 years. He worked for the State of Idaho for 12 years, and four (4) years as an HR Manager in Sonoma County. He came to Mendocino County in 2017 as a contractor for the Fire Recovery Team. He left for a short time, and when he returned, he held the position of Assistant HHSA Director. He is looking forward to his new role as HR Director, as well as working with the Commission.
