## **Historical Roots**

The Grand Jury system has been used in England since the twelfth century. Grand juries were brought to America in 1635 when the Massachusetts Bay Colony empaneled the first one in the new land.

The Grand Jury system has been embedded in the California Constitution since the beginning of statehood in 1850. The Mendocino County Civil Grand Jury operates under this constitutional mandate, which calls for a grand jury in every county.

### WHAT WE DO

The Civil Grand Jury is Mendocino County's only independent watchdog of government agencies and services. Composed of 19 citizen volunteers, it investigates and monitors the performance of County, city, and local governing entities, including special districts. It has the responsibility to make recommendations to improve local government.

The Civil Grand Jury speaks as one voice for the residents of Mendocino County.

Empowered by the judicial system, the Civil Grand Jury is independent of administrators, politicians, and legislators.

Grand Jury service is a volunteer position with modest monthly compensation for meetings and round-trip mileage. What it doesn't offer in pay, it offers in a wealth of experience.



#### THE PROCESS

Applications are accepted from all qualified citizens, reviewed by the presiding Superior Court judge, and a drawing is held to pick 19 jurors. Those not selected are placed in a pool of alternates.

*Jurors* serve for a 1-year term beginning July 1<sup>st</sup>. Serving jurors are provided with comprehensive training on grand jury responsibilities, investigation techniques and report writing.

Investigations: The Grand Jury investigates all matters ranging from inefficiencies in local government to misconduct in office by public officials. Anyone may submit a complaint by either completing a Grand Jury complaint form or by writing a letter to the Grand Jury. Complaints are treated as confidential.

*Reports:* A public report usually follows an investigation with recommendations that are publicly addressed by the recipients. To see reports issued by the Mendocino County Civil Grand Jury visit the jury's website.
