ADDENDUM NO. 1

The following clarifications will be made on the Contract as Addendum No. 1.

GENERAL:

Encroachment Permit attachment:

- For the purposes of this project any provision within the attached MCDoT Encroachment Permit which reads "*unless specifically exempted on the face of said permit*" it shall be held that the Brelje & Race Plans dated March 2020 are considered "*the face of said permit*."
- Specifically the trench details on the Brelje & Race Plans dated March 2020 control and are considered "*the face of said permit.*"
- The Brelje & Race Project Book dated March 2020 calls for a Traffic Control Submittal. That submittal is fixable as to construction on the private roads. The Encroachment Permit conditions shall ONLY apply for work done on the public MCDoT County Maintained Roads called out in the permit with regards to Traffic Operations (conveyance of traveling public) and Public Traffic Safety specifically PERMITTEE shall continually have one-way traffic open to the public. Traffic may be temporarily stopped for up to 20 minutes at a time (5 minutes preferred average delay).
- The MCDoT Encroachment Permit and fee are paid for by the OWNER. The CONTRACTOR need only apply and be issued an identical permit in their name at no additional fee.

SECTION "F" GENERAL SPECIFICATIONS:

• Replace F7-04 UNAVOIDABLE DELAYS & F8-06 NO CHARGE FOR DELAY with the attached revised sections intended to provide for conditions stemming from the COVID 19 Epidemic.

SECTION "D" PROPOSAL:

• Replace the Bid Schedule (Pages D-1, D-2 and D-3) with attached Revised Bid Schedule (Pages D-1, D-2A, D-2B and D-3) that moves the work in

Madrone Drive into a separate bid schedule (Additive Items Schedule A) and revises the basis for establishing the low bid.

SECTION "I" LIST AND DESCRIPTION OF DRAWINGS:

• Should Additive Items Schedule A <u>not</u> be awarded, the work to be performed under the agreement (exclusive of any subsequent change orders) will <u>exclude</u> all work shown on Sheets 51, 52, 53 and 54 of 54 except for the blow-off located at Station 238+23.50 shown on Sheet 54 and the 8 feet of 6-inch connecting piping to the east that terminates at the new 6-inch mainline in Madrone Lane. This piping segment between the blow-off tee and mainline tee in Madrone Lane shall be restrained, and a blind flange shall be installed on the westerly leg of the blow-off tee.

CONTRACTOR QUESTIONS AND RESPONSES:

Question (**Q**): What is the available construction area along the mains being installed easements? Who is responsible to layout the easements? **Response** (**R**): Work shall be confined to the easement area unless the Contractor provides the County of Mendocino Department of Transportation with evidence of a written agreement between the Contractor and the property owner allowing the Contractor expanded access rights. Layout of the easement limits will be accomplished by a representative of the Mendocino Department of Transportation.

Q: Is the Contractor responsible for compaction testing?
R: Compaction testing will be accomplished by a representative of the Mendocino Department of Transportation. See Section G3-09.1 of the Project Manual for Contractor's associated responsibilities.

Q: How many areas are allowed to be under construction at any one time? **R:** See Section G1-05.3 of the Project Manual for limitations on the number of areas that may be under construction at any one time.

Q: What are the disinfection requirements at tie-ins? **R:** See Section G3-14 of the Project Manual for disinfection requirements at tie-ins.

F7-04 UNAVOIDABLE DELAYS

The term "unavoidable delay" shall have the same meaning as the term "unanticipated event," as defined in the CalTrans Standard Specifications, 2018 Edition, Section 1-1.07.2.2.4. Unavoidable delays in the prosecution or completion of the work under this Contract shall include all delays which may result, through causes beyond the control of the Contractor and which he could not have provided against by the exercise of care, prudence, foresight, and diligence; cessation of work related to the current COVID-19 epidemic, as a result of material and equipment unavailability, insufficient labor due to illnesses, or pursuant to a health order, shall be considered an unavoidable delay. Orders issued by the Owner changing the amount of work to be done, the quantity of material to be furnished, or the manner in which the work is to be prosecuted, and unforeseen delays in the completion of the work of other contractors under contract with the Owner will be considered unavoidable delays, so far as they necessarily interfere with the Contractor's completion of the whole of the work. Delays due to adverse weather conditions will not be regarded as unavoidable delays in this sense, as the Contractor should understand that such conditions are to be expected and plan his work accordingly.

In the event of an unavoidable delay, Contractor shall serve notice of the delay pursuant to Section F7-06 hereof and apply for an extension of time pursuant to Section F7-07 hereof. Should an extension of time be granted pursuant to Section F7-07, any additional costs incurred by the Contractor due to delays, labor overruns, material overruns or other cost overruns related to the Work shall be addressed by a contract change order pursuant to Section F-9 hereof.

F8-06 NO CHARGE FOR DELAY

The Contractor shall have no claim for extra compensation for any hindrances or delays of work from any cause whatsoever during the progress thereof, although he may ask for an extension of the time agreed upon for completing the work. Notwithstanding the foregoing, an unavoidable delay as defined in Section F7-04 is subject to extensions of time and change order requests as stated therein.
