Hi Mark,

It has come to my attention that the first page of the petitions I sent you represented information that we originally had understood from conversation with Planning and Building, that we were told that the cell tower was in proximity to La Vida Charter School and Ridgewood Ranch. Petition to the Mendocino County Planning Commission

Please sign the petition to stop AT&T/Epic Wireless LLC from building a wireless communication facility consisting of a 143 ft. lattice tower 5.1± miles southeast of the City of Willits.

We, the residents and visitors of Mendocino County, petition the Mendocino County Planning Commission to **deny the Negative Declaration (ND) and to deny the Major Use Permit** to AT&T/Epic Wireless LLC for building a 143 ft. lattice tower 5.1± miles southeast of the City of Willits, on Pine Mountain, on the east side of Manzanita Drive (CR 304C), 0.5± miles east of its intersection with Ridgewood Road (CR 304A) located at 20201 Manzanita Dr., Willits (APN: 105-090-01). https://www.mendocinocounty.org/home/showdocument?id=32450

Due to the cumulative impacts that cannot be properly addressed in a Negative Declaration, the many environmental issues, weak conditions of approval and meaningless mitigations, this project needs an Environmental Impact Report.

The site is in a very high fire hazard zone near the Maacama earthquake fault. A potentially volatile situation is created by seasonal high afternoon winds, a generator with lithium-ion batteries (that can ignite and explode), diesel storage, electrical equipment and antenna towers that attract lightning. Future 5G (Fifth Generation) antennas and their associated EMFs, can develop high level terpenoids during calm wind and hot conditions initiating spontaneous combustion. Are the county's fire danger laws updated? Has the Pine Mountain Fire Safe Council been notified? If not, that needs to happen. Can the volunteer Little Lake Fire District respond adequately to a fire on this site? The plan does not have a response from them. Pine Mountain roads aren't adequate to ensure public safety transport in an emergency. The arterial roads leading to the site are narrower than standard egress (Manzanita Drive is 22 feet wide without shoulders) and would prohibit two-way traffic in a fire or natural disaster emergency.

The flawed Negative Declaration does not contain a biological and botanical field survey, which is needed prior to commencement of any activities that may modify vegetation (clearing, mowing or ground-breaking), especially when natural (or naturalized) vegetation occurs. This area is affected by two (not one) riparian habitats next to the project site. Unknown special status plants or sensitive natural communities occur in the project area. Ecological and socioeconomic resources are not mentioned or analyzed in the ND or Environmental Checklist. This tower would have a negative effect on people, animals and plants living in close proximity to this electromagnetic and microwave structure. Notifications from the Planning and Building Department about this wireless communication facility have only been mailed to property owners within 1,100 feet of the project. This structure enables future 5G microwave radiation capability, which travels 6.2 miles. It is vital that setbacks for notification encompass a wider area, especially in the Rural Residential (RR5) which comprises 128 parcels and numerous Upland Residential (U20) areas most proximal to the site.

Please preserve the valuable scenic corridor connecting San Francisco with the Avenue of the Giants. Willits takes pride in being the "Gateway to the Redwoods" and the "Heart of Mendocino County". The use permit documents show that the development will be visible from public vantage points (US Highway 101). This tower will compromise rural aesthetics. This communication facility will have a significant negative effect on property values.

The County's environmental checklist does not consider Health and Safety as environmental factors. The outdated (1996) Guidelines from the captured Federal Communication Commission (FCC) do not consider current health, safety and environmental concerns. As a mitigation, AT&T will place a "Caution 2B" sign next to the lattice tower. RF radiation is classified as Group 2B, a possible human carcinogen. 4G/LTE technology used with this tower forms an integral part of the 5G deployment. The FCC safety limit only protects against thermal effects of microwave radiation and is insufficient for preventing biological harm. The harmful effects of electromagnetic fields, regardless of their frequencies, are now scientifically settled. Pregnant women (the fetus), children, adolescents, and older people who are frail and whose immune systems are compromised are particularly vulnerable. Children's brains absorb more radiation than adults. The tower site will be 4.6 miles from the Willits Charter School. There have been no safety studies done by the industry that prove this technology is safe, and thousands of studies which show it is indeed unsafe. Radiofrequency affects the health of the population, environment, and quality of life. This is reflected in high rates of cancer, neurological disease, heart disease, diabetes (even in children); plummeting populations of birds, bees and butterflies; and unhealthy forests. What entity will bear legal responsibility for damage to life, limb and property arising from exposure to electromagnetic radiation? No insurance company is willing to cover damage/illness caused by electromagnetic radiation. Mendocino County signed its Precautionary Principle Policy in 2006, which states: "There is a duty to take anticipatory action to prevent harm." https://www.mendocinocounty.org/home/showdocument?id=32450

Hardwiring our communication devices protects us from 2, 3, and 4G RF. Communication plans for Mendocino County must include fiber-optic cables. These electromagnetic, radio frequency and microwave technologies must first be proven safe before we will allow them near our homes.
