## **Findings**

- 9. Buildings #1 and #2 have plumbing problems that require constant repair due to old plumbing and inmate abuse of plumbing equipment.

  Response (General Services Agency Director):
  The General Services Agency Director agrees with this finding.
- Corrections Standards Authority (CSA) Bi-Annual Inspection Report of May 5, 2010, showed the following non-compliance issues in the facility:
  - clogged floor drains,
  - · unbalanced water pressure in the hot and cold supply lines,
  - malfunctioning showers,
  - · leaking water lines,
  - heating and air conditioning units did not provide a comfortable living environment.

Response (General Services Agency Director):
The General Services Agency Director agrees with this finding.

11. A letter from the CSA, dated February 14, 2011, states that all non-compliance issues have been corrected.

12. General Services Agency provides one full time maintenance person to maintain the Facility

## Recommendations

2. The General Services Agency Director assign an additional, in-house, maintenance person to maintain and repair building problems, (Findings 9-10, 12)

Response (General Services Agency Director):

The recommendation will not be implemented because it is not warranted. GSA staff are able to keep up with all maintenance issues at the jail with the assignment of one maintenance worker. GSA does assigned another maintenance worker on a special project basis. GSA also uses outside contractors to perform specialty repairs and services as needed.
