Findings 2, 14, 15, 17, 18, 19, 20, 21:

The Mendocino County Board of Supervisors has no specific information regarding these findings and therefore incorporates by reference herein, the responses to findings prepared by the Sheriff's Office, County Executive Office, Planning and Building, and Assessor's Office.

Recommendations 1, 2, 3, 4, 6:

Cities and Counties are mutually exempt from each others zoning and regulatory ordinances (see Government Code § 53090 and 53091). The responsibility for regulation rests with the City of Ukiah.
