PUBLIC NOTICE. Sealed proposals will be received by the Transportation Department of the County of Mendocino, State of California, until the hour of **1 o'clock P.M. Friday June 5, 2020**, at which time they will be publicly opened and read aloud in the office of the **Mendocino County Department of Transportation, 340 Lake Mendocino Drive, Ukiah, California 95482** (telephone 707-463-4363) for construction in accordance with the Plans and Specifications to which special reference is made as follows:

DESCRIPTION OF WORK: The scope of work for this Project consists of the following:

- **Runway 10-28 Pavement Rehabilitation**
 - Removal of Foreign Substances and Contaminants (pavement markings and oil spill)
 - Surface Preparation
 - Crack Repair
 - Pavement Repair (upon Engineer's approval)
 - Emulsified Asphalt Slurry Seal (P-626)
 - Application of Pavement Markings
- **Runway 10-28 Shoulder Rehabilitation**
 - Unclassified excavation
 - Subgrade preparation
 - Aggregate base (P-208) placement
- **Runway 10-28 Light Repairs**
 - Replace damaged runway light lenses
 - Replace missing runway light fixtures

Bids are required for the entire work described herein.

PRE-BID MEETING: A pre-bid meeting will be held through teleconference on Wednesday, May 27, 2020 at 1 PM PDT. **Contractors interested in attending the pre-bid meeting must provide their email addresses at least two days in advance of the pre-bid meeting to Doug Asche, PE (Project Manager) at doug.asche@meadhunt.com.** This meeting is not mandatory, but bidders are highly encouraged to attend.

BIDDER / CONTRACTOR REQUIREMENTS:

1. **Contractor's License:** Bidder / Contractor must possess a valid California Contractor's License, Class A and/or combination of Class C-12 and C-32. License must be valid at the time of bid and throughout the Contract.
 - a. The successful low bidder will not be required to obtain a County Business License prior to Notice to Proceed, unless the low bidder's fixed place of business is within the unincorporated area of Mendocino County.
2. **Registered.** Per Public Works Contractor Registration Law [SB 854], Contractors and Subcontractors who intend to bid or perform work on this Project must be registered with the Department of Industrial Relations. (Information is available at <http://www.dir.ca.gov/Public-Works/Contractors.html>).
 - No contractor or subcontractor may be listed on a bid proposal for a public works project (submitted on or after March 1, 2015) unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 [with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a)].
 - No contractor or subcontractor may be awarded a contract for public work on a public works project (awarded on or after April 1, 2015) unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5.
 - This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.
3. **Federal Aviation Administration (FAA).** This project is funded under the Federal Aviation Administration (FAA) Airport Improvement Program (AIP). Contractor(s) will be required to comply with specific federal contract provisions as listed herein and contained in the Bid Documents.

(1) NOTICE OF REQUIREMENT FOR AFFIRMATIVE ACTION to ENSURE EQUAL EMPLOYMENT OPPORTUNITY

The Offeror's or Bidder's attention is called to the "Equal Opportunity Clause" and the "Standard Federal Equal Employment Opportunity Construction Contract Specifications" set forth herein.

The goals and timetables for minority and female participation, expressed in percentage terms for the Contractor's aggregate workforce in each trade on all construction work in the covered area, are as follows:

Timetables

Goals for minority participation for each trade: 23.2%

Goals for female participation in each trade: 6.9%

These goals are applicable to all the Contractor's construction work (whether or not it is Federal or federally assisted) performed in the covered area. If the Contractor performs construction work in a geographical area located outside of the covered area, it shall apply the goals established for such geographical area where the work is actually performed. With regard to this second area, the Contractor also is subject to the goals for both its federally involved and non-federally involved construction.

The Contractor's compliance with the Executive Order and the regulations in 41 CFR Part 60-4 shall be based on its implementation of the Equal Opportunity Clause, specific affirmative action obligations required by the specifications set forth in 41 CFR 60-4.3(a) and its efforts to meet the goals. The hours of minority and female employment and training must be substantially uniform throughout the length of the contract, and in each trade, and the Contractor shall make a good faith effort to employ minorities and women evenly on each of its projects. The transfer of minority or female employees or trainees from Contractor to Contractor or from project to project for the sole purpose of meeting the Contractor's goals shall be a violation of the contract, the Executive Order and the regulations in 41 CFR Part 60-4. Compliance with the goals will be measured against the total work hours performed.

The Contractor shall provide written notification to the Director of the Office of Federal Contract Compliance Programs (OFCCP) within 10 working days of award of any construction subcontract in excess of \$10,000 at any tier for construction work under the contract resulting from this solicitation. The notification shall list the name, address, and telephone number of the subcontractor; employer identification number of the subcontractor; estimated dollar amount of the subcontract; estimated starting and completion dates of the subcontract; and the geographical area in which the subcontract is to be performed.

- As used in this notice and in the contract resulting from this solicitation, the "covered area" is City of Covelo, County of Mendocino, State of California.

(2) CIVIL RIGHTS – TITLE VI ASSURANCE

The COUNTY OF MENDOCINO, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 USC §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders or offerors that it will affirmatively ensure that any contract entered into pursuant to this advertisement, Disadvantaged Business will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

(3) DISADVANTAGE BUSINESS ENTERPRISE (DBE)

A DBE Goal of **9.3%** has been established for this project/contract.

The Owner's award of this contract is conditioned upon Bidder or Offeror satisfying the good faith effort requirements of 49 CFR §26.53.

The successful Bidder or Offeror must provide written confirmation of participation from each of the DBE firms the Bidder or Offeror lists in its commitment within five days after bid opening.

- 1) The names and addresses of Disadvantaged Business Enterprise (DBE) firms that will participate in the contract;
- 2) A description of the work that each DBE firm will perform;
- 3) The dollar amount of the participation of each DBE firm listed under (1)
- 4) Written statement from Bidder or Offeror that attests their commitment to use the DBE firm(s) listed under (1) to meet the Owner's project goal; and
- 5) If Bidder or Offeror cannot meet the advertised project DBE goal, evidence of good faith efforts undertaken by the Bidder or Offeror as described in appendix A to 49 CFR part 26.

The requirements of 49 CFR part 26 apply to this contract. It is the policy of the COUNTY OF MENDOCINO to practice nondiscrimination based on race, color, sex, or national origin in the award or performance of this contract. The Owner encourages participation by all firms qualifying under this solicitation regardless of business size or ownership.

Contract Assurance (§ 26.13) –

The Contractor or subcontractor shall not discriminate on the basis of race, color, national origin, or sex in the performance of this contract. The Contractor shall carry out applicable requirements of 49 CFR part 26 in the award and administration of Department of Transportation-assisted contracts. Failure by the Contractor to carry out these requirements is a material breach of this contract, which may result in the termination of this contract or such other remedy as the Owner deems appropriate, which may include, but is not limited to:

- 1) Withholding monthly progress payments;
- 2) Assessing sanctions;
- 3) Liquidated damages; and/or
- 4) Disqualifying the Contractor from future bidding as non-responsible.

Prompt Payment (§26.29) – The prime contractor agrees to pay each subcontractor under this prime contract for satisfactory performance of its contract no later than FOURTEEN days from the receipt of each payment the prime contractor receives from COUNTY OF MENDOCINO. The prime contractor agrees further to return retainage payments to each subcontractor within FOURTEEN days after the subcontractor's work is satisfactorily completed. Any delay or postponement of payment from the above referenced time frame may occur only for good cause following written approval of the COUNTY OF MENDOCINO. This clause applies to both DBE and non-DBE subcontractors.

(4) FEDERAL PROVISIONS

The following provisions are incorporated herein by reference with the same force and effect as if given in full text:

- 1) Buy American Preference (Reference: 49 USC § 50101)

- 2) Civil Rights Title VI (Reference: 49 USC § 47123)
- 3) Davis Bacon Act (Reference: 2 CFR § 200, Appendix II(D); 29 CFR Part 5)
- 4) Debarment and Suspension (Reference: 2 CFR part 180 (Subpart C); 2 CFR part 1200; and DOT Order 4200.5)
- 5) Disadvantage Business Enterprise (Reference: 49CFR Part 26)
- 6) Trade Restriction Certification (Reference: 49 USC § 50104; 49 CFR part 30)
- 7) Lobbying and Influencing Federal Employees (Reference: 31 USC § 1352 – Byrd Anti-Lobbying Amendment; 2 CFR part 200, Appendix II(J); and 49 CFR part 20, Appdx A)
- 8) Procurement of Recovered Materials (Reference: 2 CFR § 200.322; 40 CFR part 247; and Solid Waste Disposal Act)

Successful Bidder/Contractor will be required to insert applicable federal contract provisions into all subcontracts and shall be responsible for compliance by subcontractor(s).

4. **Prevailing Wages and Payroll Records.** Contractor will be required to pay employees and keep records in accordance with the Davis Bacon Act (29 CFR Part 5) and/or the Federal Fair Labor Standards Act (29 CFR part 201).
5. **List of Subcontractors.** The prime contractor must provide a list of subcontractors with his bid on the form provided in the Proposal forms.

BID SUBMISSION. Each bid shall be in accordance with the Plans and Specifications and other Contract Documents now on file with County of Mendocino Transportation Department at the address below, for review only.

Each bidder must supply all the information required by the Contract Documents. All proposals sent by mail must be posted so as to be received by the Transportation Department of the County of Mendocino set forth above for the bid opening.


