Vacancy List

Attached to this report is an updated Justification of Filled Positions table and the Vacancy and Recruitment Update provided by Human Resources. These reports include additional information as requested by the Board of Supervisors and includes all funded allocated positions, all vacant funded positions, all positions approved to be filled, including positions in the recruitment process, all new hires (excluding extra help), all separations, and the number of employees on leave for each budget unit. The report will contain cumulative information for the current fiscal year and will be updated monthly.

Agriculture Update

While the Agricultural Commissioner/Sealer of Weights and Measures office has remained closed to the public during the Covid-19 event, the department has continued to provide essential services by appointment.

Inspectors have tested scales, issued and delivered licenses and registrations. The department is working closely with local businesses and organizations. For example, the department had to cancel the Field Working Training session scheduled in March due to public health concerns, but other businesses and organizations, like the Farm Bureau, were able to fill the void and administer the required trainings. The department has also worked closely with the Farmers' Markets to make sure that they stay open while adhering to social distancing and cleanliness requirements. The department also recently coordinated with Environmental Health to follow-up on a joint price-gouging and food-quality complaint.

The department continues to investigate complaints and perform inspections, such as pesticide business headquarters and pesticide application inspections. Plant samples have been collected from all of the shipping nurseries in Mendocino County for the annual SOD (Sudden Oak Death) recertification process. Crop Report surveys were sent out; the report is expected to be completed by late summer.

The department's propane prover was returned after receiving certification from the State DMS (Division of Measurement Standards) lab in Sacramento. Inspectors plan on sealing and certifying propane dispensers and trucks in the upcoming months, which fortunately coincides with propane business' quieter season.

Overall, staff have been able to keep up on the required inspections and certifications, often finding alternative ways of getting jobs done, such as teleworking or delivering batches of documents for customers sheltering in place. The department has heard from the local agricultural community that growers have been less impeded by the pandemic than other industries in our area.

Finally, it should be noted that most Ag businesses, when responding to calls and surveys, have said they have enough PPE supplies on hand to last through May, but have encountered very long wait times for delivery of future orders. DPR (Department of Pesticide Regulation) has surveyed our local Ag community as well and have identified that there is a real need for various kinds of PPE, but at this time, DPR has only been able to obtain surgical masks. DPR is sending the masks to the Ag office and they will distribute to agriculture operations.

Emergency Projects

On June 1, 2020, Facilities staff were called to clear a clogged sewer line in Wing 4 of the County Jail. The auger line hooked an object, and became stuck upon retrieval. The object and the line cannot be retrieved, and the floor must now be cut to expose the sewer line and clear the drain. This work has been declared an emergency to minimize the potential for delays in restoring full functionality at the Jail.

Library

The Mendocino County Library has continued to provide services during the closures related to the COVID-19 event. The Library has online and telephone assistance/reference for the public during the week. The Library has been able to provide more online resources such as Tumblebooks, Westlaw, Beanstack (an online reading program) and e-book databases. The Library has also increased the Zip Book program, increased downloadable audio books and videos via Overdrive, Kanopy and Hoopla databases. The Library was awarded special crisis funding through the State, which has allowed the Library to order and provide more audio titles available to patrons. All Library Branches are actively using social media to provide online craft and story time programs, along with other resources and fun activities for our community.

Health and Human Services Agency Status Report June 1, 2020

Behavioral Health & Recovery Services

- Continue to provide Substance Use Disorder Treatment services to clients via telephone, telehealth, limited in-person contact, and continue to provide drug testing services. Medi-Cal Expansion for Substance Use Treatment – Organized Delivery System still on schedule to begin July 1, 2020.
- The County and contracted providers continue to provide mental health services through the use of telephone and telehealth for counseling and medication services; face-to-face and crisis services are provided while adhering to social distancing requirements and using Personal Protective Equipment.
- Opened a Warm Line staffed by employees trained in crisis-response; providing telephone-based emotional support for Mendocino County residents who are feeling stressed, isolated, or overwhelmed. The Warm Line is currently available 7 days a week from 7:30 am to 6:00 pm at [1-707-472-2311](tel:17074722311) or toll free at 1-833-955-2510.

Social Services

Adult and Aging Services

- Implementing Great Plates Delivered, a meal delivery service for Mendocino County's older adults. Great Plates Delivered has two purposes: 1. To help seniors (65+) and other adults (60-64) at High Risk from COVID-19, (having documented exposure to COVID-19 or underlying health condition) to stay home and stay healthy by receiving three restaurant-provided nutritious meals a day. 2. To provide essential economic stimulus to local businesses struggling to stay afloat during the COVID-19 crisis. As of May 28, the Great Plates program is delivering 688 meals a day and overall 5920 meals have been delivered since the beginning of the program. Seniors can also apply online at mendocinocounty.org/greatplates.

- Public Authority – Continue IHSS provider orientation trainings and fingerprinting, while maintaining all social distancing protocol.
- Continue to track COVID-19 calls from In Home Supportive Services (IHSS) clients and respond to emergent needs within 24 hours.
- Continue to distribute gloves and masks to all essential IHSS Workers.
- Continue to provide critical essential services to clients.

Family and Children's Services

- Continues to facilitate family visits between children in foster care and their parents, siblings and other relatives virtually through phone and/or video conference. In-person visits are arranged, if appropriate, on a case-by-case basis after an assessment to ensure the health and safety of all visiting parties, supervising staff and the foster caregivers.
- Continues to support children, young adults and families involved in our dependency system through constant contact with their social worker and/or other Family and Children's Services staff via telephone and video conferencing.
- Dependency court hearings continue to occur and Family Dependency Drug Court hearings resumed on May 6th.
- Continues to provide mandated services to respond to child abuse and neglect referrals and meet the needs of clients, while maintaining the safety and protection of all individuals. Social Workers conducting abuse and neglect investigations are provided with Personal Protective Equipment to wear and have also been provided with guidelines from the State to safely conduct investigations while still ensuring child safety.

Employee & Family Assistance Services

- CalFresh applications are screened for immediate need or expedited service and all necessary interviews are conducted via telephone.
- Pandemic EBT (P-EBT) program: Children eligible for free or reduced-priced school meals and whose school facilities have been closed due to COVID-19 will be eligible to receive Pandemic EBT (P-EBT) for the purchase of food. For those children who are also receiving CalFresh, Medi-Cal, or Foster Care benefits, a separate, state-issued EBT card was sent without the need to apply. Families started to receive P-EBT cards between May 12 and May 22. Families with children who are eligible for free and reduced-price meals who did not get their P-EBT card in the mail by May 22, 2020 will have until June 30, 2020 to apply online. Households can receive up to \$365 in P-EBT benefits for each eligible child. Visit www.cdss.ca.gov/pandemic-ebt to learn more.
- Activated Electronic Benefits Transfer (EBT) online purchasing for CalFresh recipients on April 28, 2020 to allow the online purchase of groceries through participating retailers, including Wal-Mart and Amazon.
- Additional April CalFresh Emergency Allotments for households were issued on April 12 and May 10 to bring households up to the maximum benefit level for the household size. This resulted in a \$1,324,349 increase in CalFresh

benefits for this county over two months- emergency allotments will issue again on June 14.

- While incoming CalFresh and CalWorks applications have increased, the State has allowed some administrative waivers to ensure that counties can process the applications in a timely manner, including the waiving of interview requirements for some CalFresh households and the expansion of telephonic signatures. In particular, there was a significant increase in new applications for CalFresh for the month of April, almost double the amount in comparison with the same period last year, which resulted in a 10% increase in our CalFresh caseload overall.
- CalWORKs Homeless Assistance and Housing Support Programs provided over \$90,000 in direct shelter payments for families with children in the months of April and May.

Advocacy and Collaboration Team (ACT)




- Continue to manage the local implementation of California's Project Roomkey, which aims to provide motel and hotel rooms to high-risk unhoused individuals who meet specific criteria as a protection from COVID-19 spread. To date, this program has worked closely with community partners to shelter and case-manage 212 high-risk homeless adults and 27 children in local motels. At this time, staff is working closely with community-based partners to begin the process of planning exit strategies for each individual and family to a location other than the street.
- Working with community partners, visited homeless encampments at the beginning of the Shelter-in-Place order, to inform residents of safety protocols, while screening for high risk criteria, including taking note of people over 65. The Ukiah encampment was re-screened on April 22, 2020. HHSA staff have since been working collaboratively with the City of Ukiah and the Ukiah Police Department to support the City of Ukiah's efforts to address the public health and safety issues at the encampment. HHSA staff have coordinated a collaborative event with community service providers to offer support to encampment residents on June 3 and 4th.
- Continue to work collaboratively with the Board of the Continuum of Care to utilize pandemic-related funding to support the local implementation of Project Roomkey, as well as critical needs of our homeless individuals countywide, including those fleeing domestic violence.
- Continue to prepare and distribute a weekly resource guide, entitled "Resources - What We Know Now", to community-based organizations and interested individuals county wide. This document is translated into Spanish, updated weekly and is posted on the County's COVID-19 website, and is also shared on numerous local organization websites and social media accounts.
- Working collaboratively with First5 Mendocino, Project Sanctuary, Adventist Health, and Redwood Community Services, ACT staff facilitated the development of printed materials designed to reach individuals and families struggling with

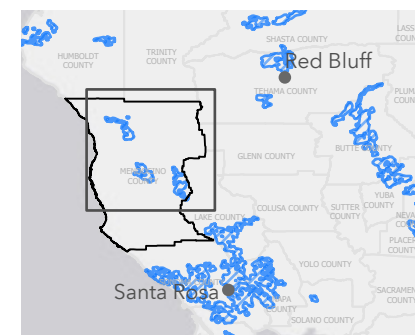
stress, mental health, and/or domestic violence. 10,000 cards have been printed and will be distributed to grocery stores and through school meal programs countywide. New editions will be printed and distributed throughout the course of the pandemic.

Public Health

- Leading the Public Health response to COVID-19, including maintaining the Department Operations Center, which: tracks COVID-19 cases within the county; conducts thorough contact tracing to slow spread; facilitates COVID-19 testing via Optum Serv, in addition to other targeted testing according to public health need; monitors public concerns and questions regarding COVID-19 in our county via social media, press conferences and the Call Center; secures Personal Protective Equipment, tests and relevant couriers; collaborates with different labs in the region to ensure testing continues at the rate necessary; and researches and secures available emergency funding.
- Maintained other communicable disease interventions during COVID-19 incident oversight.
- Continued Women Infant & Children (WIC) services, providing nutrition assistance to income eligible parents, pregnant or breastfeeding women county-wide.
- Community Wellness staff assisted key essential services to help insure maximum performance surrounding the COVID-19 pandemic in addition to continuing to complete program requirements and reports for prevention programs.
- Participated in community outreach via KGUA radio, touching on timely topics such as COVID-19 updates, immunizations, etc.
- Healthy Families Mendocino County Home Visiting has maintained supportive contact for 35 participant families and 7 active referrals during COVID-19. This is an exceptional reflection on dedicated HFMC nurses and home visitors who have also deployed to EOC or DOC. HFMC clients include women leaving situations of interpersonal violence, a mother needing bilingual support to receive services for developmental delay, and many families seeking support for depression and anxiety during this challenging time. From March through May, the team provided 59 tele-visits, 19 home visits, 28 phone contacts, 56 mailings and 244 text contacts.

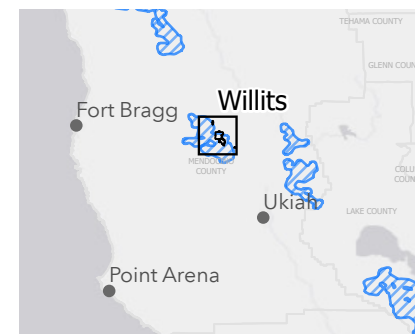

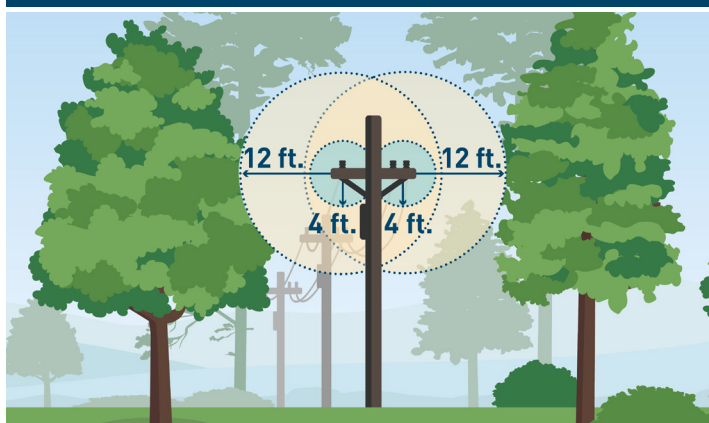

Working Together To Keep Trees Away From Power Lines

In response to the growing wildfire threat, PG&E has **expanded and enhanced our vegetation and safety work** through the Enhanced Vegetation Management (EVM) Program. This includes addressing vegetation that poses a high potential for wildfire risk in high fire-threat areas. This work is one of many precautionary measures PG&E is taking as part of our comprehensive Community Wildfire Safety Program.

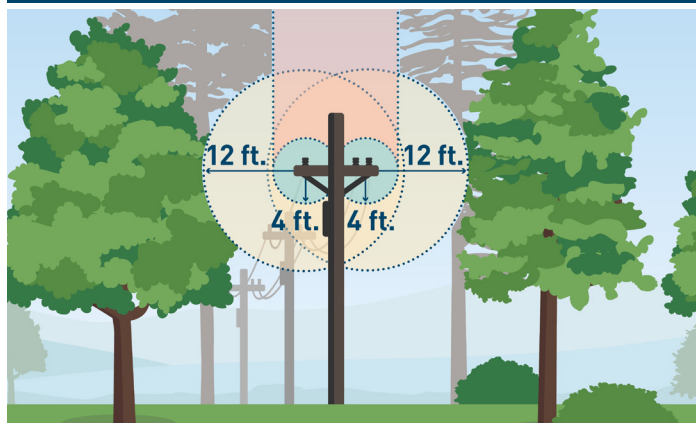
ROUTINE VEGETATION MANAGEMENT PROGRAM



Through our annual Routine Vegetation Management Program, we will continue to:

- ✓ Meet important state vegetation and fire safety standards for **minimum clearances around the power line**
- ✓ **Remove hazardous vegetation** such as dead or dying trees that pose a potential risk to electrical equipment

ENHANCED VEGETATION MANAGEMENT PROGRAM



In addition to our routine compliance work and as part of our EVM Program, we will continue to:

- ✓ **Exceed state standards** for minimum clearances around the power line
- ✓ **Prune overhanging limbs or branches** up to the sky, including those that are 4 feet out from the lines
- ✓ **Evaluate the condition of trees** that may need to be addressed if they are tall enough to strike electrical equipment

Program Status

In 2019, we cleared 2,498 distribution line miles through our EVM Program. In 2020 and beyond, PG&E's EVM work will continue throughout other high fire-threat areas across the service territory through a multi-year effort.

Further Enhancing Our Safety Efforts to Mitigate Wildfire Risk

In addition to our EVM work, we are also focusing on vegetation work around our lower-voltage transmission lines. This work includes expanding right-of-ways and removing incompatible vegetation or any trees that are identified as likely to fall into electrical equipment. These efforts will reduce wildfire risk and help to minimize the frequency, scope and duration of Public Safety Power Shutoff (PSPS) events.

What Customers Can Expect

We are reaching out to customers in advance of our EVM work through postcards, door knocks and doorhangers. We will work together with our customers to review the vegetation safety work on their property and answer questions.

Frequently Asked Questions

How often is PG&E required to inspect lines?

PG&E's service area includes an estimated 120 million trees with the potential to grow or fall into our overhead power lines. Every year, we inspect vegetation along every segment of almost 100,000 miles of overhead electric power lines, with some locations patrolled multiple times a year. We prune or remove approximately 1.4 million trees annually to help keep the lights on and our customers safe.

How long will it take to complete the EVM work?

We are working safely and as quickly as possible to perform this important safety work, prioritizing those communities that have the most extreme potential risk of wildfire. We will then be expanding our work to other high fire-threat areas across our service territory through a multi-year effort. This equates to over 25,000 miles of distribution line from Bakersfield to the Oregon border. The timing for work in a community will depend on the wildfire risk in that area, the specific work needed, the topography, access and environmental considerations of an area, as well as conversations with customers regarding plans for their property, among other factors.

Will PG&E remove the wood debris generated as part of EVM work?

Wood from this enhanced vegetation safety work is eligible for removal at no cost to our customers, if accessible. Customers who would like us to remove the wood debris from this work will receive a Request for Wood Management form at the time of inspection. The Request for Wood Management form is also available at pge.com/enhancedveg. Completed forms will need to be returned to the safety inspector or emailed to wildfiresafety@pge.com prior to the tree work beginning. Once we have received a signed request form and the tree work is complete, we plan to begin wood debris removal within a few weeks, depending on weather, access or other schedule constraints.

What additional improvements are you making to help reduce the threat of wildfires?

As part of our Community Wildfire Safety Program, we are focusing on immediate and comprehensive actions to upgrade our infrastructure, monitor fire threats in real time and institute new vegetation wildfire safety measures on lower voltage transmission lines. 
