# MENDOCINO COUNTY BOARD OF SUPERVISORS' RESPONSE TO GRAND JURY REPORT TITLED:

## IMPACT OF PUBLIC SAFETY REALIGNMENT ACT OF MENDOCINO COUNTY

### **FINDINGS:**

F3 - Realignment may cause overcrowding at the current County Jail.

The Board of Supervisors disagrees in part with this Finding. Anything "may" happen. At the present time, the Sheriff's office has implemented policies and procedures to offset any increase in the number of inmates that may have resulted from Realignment.

F4 - Violent incidents have increased at the County Jail due to the inability to separate different classifications of inmates.

The Board of Supervisors disagrees in part with this Finding. The rate of serious assaults in the jail has not substantially increased since the implementation of Realignment. Any increase is attributable to a multitude of factors, including increased sophistication of the inmates.

F6 - There is a lack of available space for: inmate housing, the visitors' center, and attorney consultation rooms at the County Jail.

The Board of Supervisors disagrees in part with this Finding. While the space is tight, the jail personnel have adjusted so that there is a sufficient room for all state mandated activities.

### **RECOMMENDATIONS:**

R1 - Mendocino County assign high priority to funding for increased housing for inmates. (F3, F4, F5, F6)

This Recommendation requires further analysis as it is unclear what additional funding the jail may need at this time. Six months should be sufficient time for the appropriate staff to analyze the situation and determine what needs are not being met within the current budget.

The adequate funding of the jail is always a high priority for the County.

R2 - Mendocino County assign high priority to funding for an expanded visitors' center and attorney consultation rooms. (F6)

This Recommendation requires further analysis as it is unclear what additional funding the jail may need at this time. Six months should be sufficient time for the appropriate staff to analyze the situation and determine what needs are not being met within the current budget.

The adequate funding of all state or federal mandate activities, including visitation with family, friends and attorneys, is always a high priority for the jail.

# R3 - Mendocino County continue to use and expand current and emerging technology designed for jail management and staff safety. (F4)

This Recommendation will continue to be implemented on an on-going basis in that the County will continue to evaluate all ways to safely and more efficiently manage the jail.
