#### **GRAND JURY FINDING NO. 34. STATES:**

When questioned about missing and incomplete Incident Reports and his repeated failure to promptly contact law enforcement, the incumbent administrator responded, "Talk to my attorney about that. The Civility Policy is interpretive." In response to several other questions, the incumbent administrator also repeatedly advised the Grand Jury to "...talk to my attorney."

#### DISTRICT ATTORNEY RESPONSE TO FINDING NO. 34.

I have no knowledge upon which to form an opinion of whether I agree or disagree with Finding No. 34. The District Attorney does not know whether the incumbent administrator failed to complete Incident Reports, failed to contact law enforcement, or made certain statements directing the Grand Jury to speak to his attorney, or whether he claimed the Civility Policy is interpretive.

#### **GRAND JURY RECOMMENDATION NO. 13 STATES:**

The Mendocino county Sheriff's Office require that deputies assigned to the North County familiarize themselves with the Leggett Valley Unified School District civility Policy and that they respond promptly to calls and arrest all violators of the Education and Penal Code Sections included in the District Civility Policy. (Findings 20, 30-34)

#### DISTRICT ATTORNEY RESPONSE TO RECOMMENDATION NO. 13.

The Required Responses in the Grand Jury Report includes Recommendation No. 13. It is the opinion of the District Attorney that the Grand Jury expected the District Attorney to respond to Recommendation No. 14 because No. 13 pertains to the authority of the Mendocino County Sheriff. The District Attorney does not respond to assault calls or arrest violators of the Education and Penal Code; our office prosecutes the crimes.

### **GRAND JURY RECOMMENDATION NO. 14 STATES:**

The Mendocino County District Attorney's Office prosecute all violations of the Leggett Valley Unified School District Civility Policy to the full extent of the law. (Findings 30-34)

### DISTRICT ATTORNEY RESPONSE TO RECOMMENDATION NO. 14.

Although the Grand Jury did not require the District Attorney to respond to No. 14; the District Attorney's Office will prosecute violations of the Education and Penal Code sections referred to in the Civility Policy so long as the evidence submitted to the Office is sufficient to prove a crime has been committed.

Attached and enclosed please find my responses to the Grand Jury's report entitled:

Abdication of Leadership and Disciplinary Breakdowns in Leggett Valley Unified School District

The Grand Jury requires me to respond to Findings #20 and #30-34 along with Recommendation #13.

#### **Findings**

20. In several interviews, respondents openly discussed the robust local marijuana industry. Some observed that it creates a general disrespect for authority on the part of students and adults. Jurors were told that students are sometimes used by their families as sentries and informants. Involvement in production of illegal drugs was also cited as undermining academic motivation and working at cross-purposes with the public school mandate to maintain a drug free environment.

Sheriffs Response: I agree with this finding.

30. Education Code 32211(a) authorizes the school principal or the designee of the principal to request any person whose presence the principal believes will be disruptive or interfere with classes of the public school program to leave the grounds. The person who is

requested to leave has the right to appeal the determination to the superintendent. That appeal shall be made no later than the second succeeding school day and a reply shall be given within 24 hours.

Sheriffs Response: I agree with this finding.

31. Education Cede 44810(a) states that "Every minor over 16 years of age or adult who is not a pupil of the school, including but not limited to any such minor or adult who is the parent or guardian of a pupil of the school, who comes upon any school ground or into any schoolhouse and there willfully interferes with the discipline, good order, lawful conduct or administration of any school class or activity of the school, with intent to disrupt, obstruct, or to inflict damage to property or bodily injury upon any person, is guilty of a misdemeanor". This section further sets forth penalties including fines of up to \$1,000 and imprisonment for up to 90 days in the county jail.

Sheriffs Response: I agree with this finding.

32. Education Code 44811 states that "Any parent, guardian, or other person whose conduct in a place where a school employee is required to be in the course of his or her duties materially disrupts class work or extracurricular activities or involves substantial disorder is guilty of a misdemeanor."

Sheriffs Response: I agree with this finding.

33. The LVUSD Civility Policy specifies that "when violence is directed against an employee or theft against property, employees shall promptly report the occurrence to their principal or supervisor and complete an Incident Report. Employees and supervisors should complete an Incident Report and report to law enforcement, any attack, assault, or threat made against them on School/District premises.

Sheriffs Response: After reviewing the Civility Policy I agree with this finding.

34. When questioned about missing and incomplete Incident Reports and his repeated failure to promptly contact law enforcement, the incumbent administrator responded, "Talk to my attorney about that. The Civility Policy is interpretive. "In response to several other questions, the incumbent administrator also repeatedly advised the Grand Jury to "Talk to my attorney."

Sheriffs Response: Without knowing the specific act or inactions I am unable to either agree nor disagree with this finding.

#### **RECOMMENDATIONS:**

13. The Mendocino County Sheriffs Office require that deputies assigned to the North County familiarize themselves with the Leggett Valley Unified School District Civility Policy and that they respond promptly to calls and arrest all violators of the Education Code and Penal Code Sections included in the District Civility Policy. (Findings 20, 30-34)

Sheriffs Response: Sheriffs deputies will continue to follow the law as set by State and Federal guidelines. Sheriffs deputies will try and maintain knowledge as to local school district guidelines and policies as well as contact with school administrators.

We recommend the beginning of each school year the Leggett Valley Unified School District Superintendent meet with the Mendocino County Sheriff's Office North Area Commander to review the Leggett Valley Unified School District Civility Policy and discuss any revisions.

#### Civility Policy

Members of LVUSD staff will treat parents and other members of the public with respect and expect the same in return. The District is committed to maintaining orderly educational and administrative processes in keeping schools and administrative offices free from disruptions and preventing unauthorized persons for entering school/district grounds.

This policy promotes mutual respect, civility and orderly conduct among District employees, parents, volunteers, students, and the public. This policy is not intended to deprive any person of his/her right to freedom of expression, but only to maintain, to the extent possible and reasonable, a safe, harassment-free workplace for our students, volunteers and staff. In the interest of presenting District employees as positive role models to the children of this District, as well as the community, LVUSD encourages positive communication, and discourages volatile, hostile or aggressive actions. The District seeks public cooperation with this endeavor.

#### Disruptions

- 1. Any individual who disrupts or threatens to disrupt school/office operations; threatens the health and safety of students, volunteers or staff; willfully causes property damage; uses loud and/or offensive language; or who has otherwise established a continued pattern of unauthorized entry on school district property, will be directed to leave school or school district property promptly by the Chief Administrative Officer or designee.
- 2. If any member of the public uses obscenities or speaks in a demanding, loud, insulting and/or demeaning manner, the administrator or employee to whom the remarks are directed will calmly and politely admonish the speaker to communicate civilly. If corrective action is not taken by the abusing party, the District employee will verbally notify the abusing party that the meeting, conference or telephone conversation is terminated and, if the meeting or conference is on District premises, the offending person will be directed to leave promptly.
- 3. When an individual is directed to leave under such Paragraph 1 or 2 circumstances, the Chief Administrative Officer or designee shall inform the person that he/she will be guilty of a misdemeanor in accordance with California Education Code 44811 and Penal Codes 415.5 and 525.7, if he/she reenters any district facility within 30 days after being directed to leave, or within seven days if the person is a parent/guardian of a student attending that school. If an individual refuses to leave upon request or returns before the applicable period of time, the Chief Administrative Officer or designee may notify law enforcement officials. An Incident Report should be completed for the situations as set forth in paragraphs 1 and 2.

#### Safety and Security

4. When violence is directed against an employee, or theft against property, employees shall promptly report the occurrence to their principal or supervisor and complete an incident Report. Employees and supervisors should complete an incident Report and report to law enforcement, any attack, assault or threat made against them on School/District premises

An employee whose person or property is injured or damaged by willful misconduct of a student, may ask the District to pursue legal action against the student or the student's parent/guardian.

#### Documentation

When it is determined by staff that a member of the public is in the process of violating the provisions of this policy, an effort should be made by staff to provide a written copy of this policy, including applicable code provisions, at the time of occurrence. The employee will immediately notify his/her supervisor and provide a written report of the incident on the attached
