SUMMARY OF PENAL CODE 933.05

Penal Code § 933.05 provides for only two (2) acceptable responses with which agencies and/or departments (respondents) may respond with respect to the **findings** of a Grand Jury report :

- **1.** The respondent agrees with the finding.
- 2. The respondent disagrees wholly or partially with the findings, *in which case the respondent* shall specify the portion of the finding that is disputed and shall include an explanation of the reasons therefore.

Penal Code § 933.05 provides for only four (4) acceptable responses with which agencies and/or departments (respondents) may respond with in respect to the **recommendations** of the Grand Jury.

- 1. The recommendation <u>has</u> been implemented, with a summary regarding the implemented action.
- 2. The recommendation <u>has not</u> yet been implemented, but will be in the future, with a timeframe for implementation.

Response to Findings

- In regard to **Finding #4**, we disagree with the statement regarding student access to arts, science and foreign language. Although there is a small percentage of students who require an additional math course so that they are successful in the regular math program, all other BGMS students participate in elective courses. In addition, students who take an additional math course have access to the after school Kids Club program which provides enrichment activities and to after school sports as well.
- In regard to **Finding #84**, we disagree to the statement that all students take two language arts classes and two math classes. All students who attend BGMS take two periods of language arts; however, not all students at BGMS take two periods of math. Only a small portion of students at the school take an additional math class.

Response to Recommendations

Recommendations Implemented:

- #2: The school site emergency plan has been updated to include telephone and email contacts for all radio and television stations that broadcast in the county.
- #3: The school site emergency response plan has been updated to designate the custodial staff to ensure that working fire extinguishers are in place in all classrooms and common areas at all times when students are present.
- #4: WUSD wrote and was awarded a federal violence and drug prevention grant that began July 1, 2009. This grant will provide students in WUSD a 32 hour per week Marriage and Family Therapist who will provide mental health counseling, Associate Behavior Specialists who will work with parents of students aged 0 5, and an alcohol and drug counselor, among other portions of the grant. This four year grant will provide services to students in Laytonville, Willits and Round Valley and equals \$731,000 annually in grant funding. We are excited about this grant and will continue to seek additional grant funding for library and prevention activities.
- #6: WUSD will continue to implement the Professional Learning Communities structure across the district and will continue to provide content specific staff development to teachers.
- #7: WUSD will continue to partner with the Willits Kids Club to provide an after school program that is open until 6:00 PM each day. In addition, despite cutting over \$2 million from our budget, we continue to maintain our after school sports programs.
- #10: BGMS has been working diligently with a group of parents to increase partnerships with parents. In addition, BGMS has been partnering with the local nursery to beautify its campus. Finally, WUSD has reformed its educational foundation which is readying itself to embark on a fundraising campaign and Adopt-a-School program.

Recommendations NOT Implemented:

- #1, #8, and #9 are not relevant to WUSD.
- #5: WUSD has faced devastating budget reductions over the past several years, the most recent being from February through July having to cut over \$2 million from a \$17 million budget. Through regular inspections of school sites, the District does what it needs to make sure that no hazardous conditions exist for students. If any hazardous conditions are identified, they are repaired immediately. WUSD is in the process of creating a Facilities Master Plan which will be completed in November 2009. We are also in the process of discussing a Proposition 39 General Obligation Bond election for June 2010. If the election is declared and it passes, we will be able to modernize our campuses and possibly look at renewable energy implementation across the district. On the list to update asphalt surfaces at several campuses; however, I want to reiterate that WUSD is quick to correct any surfaces that pose hazardous safety conditions for kids.
