1. Suggested verbiage added to .110 (D) pg 23:	"obtaining and complying with an	Deleted: 🗓
approved and applicable permit, license or registration		

- 2. **Suggested verbiage added** to .090 (I) pg 21: "...including access roads, water supply, grading or terracing impacts the bed or bank of any stream or other watercourse, show proof they have notified the California Department of Fish and Wildlife (CDFW) pursuant to §1602 of the Fish and Game Code and provide a copy of the Streambed Alteration Permit obtained from the Department of Fish & Wildlife.
- 3. **Suggested verbiage added** to .090 (H) pg 21: "...North Coast Regional Water Quality Control Board demonstrating enrollment in <u>and compliance with (or proof of exemption from)</u> Tier 1, 2 or 3, North Coast Regional Water Quality Control Board Order No. 2015-0023, or any..."
- 4. Remove deletions off .110 (F) ? pg 24 (per H2O Bd recommendations and GGSC goahead on 7-8-2016) Discussion item on 7-12-2016 BOS meeting.

## Possible Items to Carry Over From Current 9.31 (U.O.)

- A. Change minimum age of employees of Cooperative/Collectives from 18 to 21 (.060 (B) pg 9.
- B. Include requirement for ID card/# from applicant.
- "A unique identifying number from a State of California Driver's License or Identification Card for each person applying for the permit and any other person who will be engaged in the management of the collective"
- C. Proof: applicant and others engaged in management of collective are 21 years old.
- "Written evidence that each person applying for the permit and any other person who will be engaged in the management of the collective is at least twenty-one (21) years of age"
- D. No violent felony: applicant and others engaged in management of collective. (in application).
- E. Outright statement of security measures for safety and theft prevention. (in application).
- F. CO-OP info. (in application).

## G. Proof of need to cultivate.

"The applicant shall provide proof of either, a physician recommendation that the amount to be cultivated is consistent with the applicant's medical needs, the needs of the patients for whom the applicant is a caregiver, or a written agreement or agreements, that the applicant is authorized by one or more medical marijuana dispensing collectives to produce medical marijuana for the use of the members of said collective or collectives"

H. Authorize request for addnl. information in permit application.

"That the Agricultural Commissioner is hereby authorized to require in the permit application any other information reasonably related to the application including, but not limited to, any information necessary to discover the truth of the matters set forth in the application"

I. BOE seller's permit.

"Apply for and obtain a Board of Equalization Seller's Permit and collect and remit sales tax to the Board of Equalization if applicant intends to sell directly to qualified patients or primary caregivers"
