Directions to the County of Mendocino Administrative Center

From the North:

- ➤ Take HWY 101 to the North State Street exit.
- Follow South along State Street to Low Gap Road (3rd light.)
- Take a Right on Low Gap Road to the stop sign.
- ➤ Go straight at the stop sign. On the Left will be the main entrance to the County Buildings.
- ➤ The Board of Supervisors Chambers is located through the main doors (adjacent to the round-a-bout) and half way down the hall on the left.

From the South:

- Take HWY 101 to the Perkins Street exit.
- Take a Left over the freeway and then a Right at the light (Orchard Street.)
- > Follow Orchard Street past Kohl's department store, over a little bridge and then into a sharp left turn onto Brush Street.
- ➤ Brush Street becomes Low Gap Road after the light at State Street.
- ➤ Go through the light, to the stop sign.
- ➤ Go straight at the stop sign. On the Left will be the main entrance to the County Buildings.
