RESPONSIBILITY: Mendocino County is a General Law County governed by the Constitution of the State of California. The Mendocino Board of Supervisors is responsible for exercising its legislative and quasi-judicial authority, within budgetary constraints, to provide for the health, welfare and safety of the residents of Mendocino County. This is accomplished through regular and special Board meetings, by community outreach and interaction with their constituents, and by serving on a number of local, state, and national boards and commissions.

BACKGROUND: Supervisor Hamburg has resided in Mendocino County since 1971 and has served the community as City of Ukiah Planning Commissioner, a Mendocino County Supervisor from 1981 to 1984 and from 2011 to 2014, and as an Executive Director of North Coast Opportunities, a bi-county community action agency. Dan was elected to the House of Representatives in 1992, representing a largely coastal district that stretched from the Oregon border to the North Bay.

Supervisor Hamburg represents the Board of Supervisors as Vice Chair on the Sonoma Clean Power Board of Directors, Chair of the North Bay North Coast Broadband Consortium, the Economic Development and Finance Corporation, the Mendocino Solid Waste Management Agency, the Local Agency Formation Commission, the Russian River Watershed Association, the Behavioral Health Advisory Board and the First 5 Commission.

DISTRICT INFORMATION: The Fifth Supervisorial District encompasses southern inland and various coastal areas of Mendocino County, representing approximately 17,000 constituents.
