### **Scope of Work:**

Provide all labor, materials, and equipment to complete the following:

Contractor will uninstall, remove and properly dispose of the existing HVAC split unit from the Mendocino County WISC roof and Server room. Contractor will evaluate heating/cooling requirements for space. Contractor will provide new replacement unit of equal or better performance rating including complete installation and start-up, connection, and interface to a new thermostat control. Contractor will provide and install new electrical, mountings, flashing(s), adapter curb, conduit(s), disconnect, control panel and thermostat. Contractor will provide and install new copper condensate line from unit to gutter, properly secured to new DURA-BLOKs (or approved equivalent). The new complete system shall be in compliance with all applicable codes, Title 24, and industry standards. Acceptable manufacturers include American Standard, Trane, Bryant, or approved equivalent. Contractor will provide weatherproof/watertight attachment. All mechanical, supports, and attachments are to be unit specific, new, exterior-rated and commercial grade. The contractor is required to fulfill the requirements of a Mendocino County building permit (owner provided).

A valid current Mendocino County Business License is required for this project.

The licensed Contractor is responsible for coordination of work with the appropriate departments of the County. Work shall be in compliance with all applicable codes and industry standards. Where existing is not within specification, or out of code compliance notify the County project manager before proceeding.
