
#### INQUIRIES AND CLARIFICATIONS TO PROJECT PLANS AND SPECIFICATIONS

- 1. Q: Existing floor plan does not show the office inside the children's area. Does this area Paint?
  - A: Yes, See attached sheet SK1 showing approximate size and location of the children's librarian office. All wall surfaces inside and outside this office shall be painted. Stain wood door to match laminate door color.
- 2. Q: Painting Note 6 states to paint wood or metal door frames. Door frames appear to be laminate or bronzed aluminum. Do these door frames paint?
  - A: No, do not paint laminate or bronzed aluminum door frames. Paint wood frames and stops at children's librarian window.
- 3. Q: Are the vertical rainbow panels in the children's room light well to be painted?
  - A: No.
- 4. Q: Have colors been selected for this project? Will all walls be painted the same color?
  - A: Provide two colors for the walls. All walls below the 10' ceiling height shall be white to match the existing white in the teen room. The high east wall shall be brown to match the wood slats.
